This Easement, made this 16 day of JUNE, 1983 by KINWEST DEVELOPMENT CORPORATION ("Grantor"), a Texas corporation whose address is 225 East John W. Carpenter Freeway, Suite 550, Irving, Texas 75062, Attention: Vice President,

W I T N E S S E T H:

WHEREAS, Grantor is the owner of those certain tracts of land (collectively the "Club Tract") located in Dallas County, Texas, and more particularly described in Exhibit A attached hereto and made a part hereof for all purposes; and

WHEREAS, Grantor is constructing a golf course, country club and certain other improvements on the Club Tract, among which other improvements are dams, canals, and other facilities for controlling the flow of surface waters over the Club Tract; and

WHEREAS, under the terms and conditions of that certain Declaration recorded in Volume 73166, Page 1001, of the Deed Records of Dallas County, Texas, such Declaration as now and hereafter amended, corrected and supplemented being hereinafter referred to as the "Declaration", THE LAS COLINAS ASSOCIATION ("Grantee"), a Texas non-profit corporation whose address is 4950 North O'Connor Boulevard, Suite 135, Irving, Texas 75062, is responsible for promoting the health, safety and welfare of the owners of land covered by the Declaration; and

WHEREAS, the drainage facilities now and hereafter located on the Club Tract are an integral part of the surface water drainage system in the area in which the Club Tract is located, which area includes land covered by the Declaration; and

WHEREAS, Grantee therefore has an interest in the construction and maintenance of such existing and future drainage facilities;

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant, sell and convey to Grantee, its successors and assigns, a perpetual, non-exclusive easement on, over, across and under the Club Tract for the purposes of:

- (a) repairing, maintaining and replacing all surface water drainage facilities now located or hereafter constructed on the Club Tract, whether constructed by Grantor, Grantee or others, including, without limitation, dams, dikes, ponds, channels, outfalls and other similar and dissimilar structures and facilities; and
- (b) constructing new surface water drainage facilities on the Club Tract subject to obtaining the prior written approval of the owner(s) of the Club Tract, which approval shall not be withheld or unreasonably delayed so long as such new facilities would be compatible with the golf course and country club facilities located thereon;

subject to the following terms and conditions:

1. Grantee shall not be obligated to construct, repair, maintain or replace any such structures and facilities, but shall have the right to do so at its option and expense.
2. Grantee, at its expense, shall repair any damage caused to the Club Tract by the exercise of this Easement. Grantee shall indemnify and hold harmless the owner(s) of the Club Tract from and against any and all mechanic's and materialman's liens filed against the Club Tract in connection with work done pursuant to Grantee's exercise of this Easement.

3. In exercising its rights under this Easement, Grantee shall use reasonable efforts to minimize interference with the use of the golf course and country club located on the Club Tract and to maintain the integrity of the golf course and country club facilities.

4. Grantor, its agents, employees, tenants, invitees, successors and assigns shall not erect or maintain any barriers, impediments or obstructions of any kind on the Club Tract which would interfere with the flow of surface water through the surface water drainage facilities located thereon or unreasonably interfere with Grantee's exercise of its rights under this Easement.

5. The grants, covenants and conditions set forth herein shall be covenants running with the land and shall be binding upon and inure to the benefit of Grantor and Grantee and their respective mortgagees, successors and assigns.

6. If any term, covenant, condition or provision of this Easement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the terms, covenants, conditions and provisions hereof shall remain in full force and effect and shall not be affected, impaired or invalidated thereby.

7. No right or remedy herein conferred to Grantee is intended to be exclusive of any other right or remedy that Grantee may have, and each right or remedy herein shall be cumulative of any other right or remedy existing at law, in equity, by statute or within the Declaration.
